## **NOTICE REGARDING SCHOLARSHIP**

All the students are hereby notified that our institution (SIKSHA BIKASH SEBA FOUNDATION B.ED. & D.EL.ED. COLLEGE) ) has been registered on NSP and for other scholarship programmes like Swami Vivekananda Merit-cum-Means Scholarship –SVMCM (For students who belong to backward families), Aikyashree Scholarship (For Minorities), Oasis Scholarship (for SC, ST, OBC students). Interested and eligible students are requested to visit the respective scholarship websites to apply.

### **Eligibility Criteria for the above-listed scholarships:**

#### **Aikyashree Scholarship Eligibility Criteria:** (<https://wbmdfcscholarship.org/>)

##### **For Pre-matric Scholarship and Post-matric Scholarship**

- ❖ Applicant must be a domicile of West Bengal.
- ❖ Must be studying in a School/ Institution recognized by an educational Board/ Council/ University of the State/ Central Government.
- ❖ Must have secured not less than 50% marks or equivalent grade in the previous final examination.
- ❖ The annual family income should not exceed Rs.2 lakh.
- ❖ Students studying in institutes outside West Bengal will not be eligible for pre-matric or post-matric scholarship.

##### **For Merit-cum-Means Scholarship**

- ❖ The applicant must be a domicile of West Bengal.
- ❖ Must have got admission in a technical / professional course.
- ❖ Must have secured at least 50% marks in the last Higher Secondary/Graduation examination.
- ❖ The annual family income of the student should not be more than Rs.2.5 lakh.
- ❖ The students, who are residents of West Bengal but pursuing studies in listed institutions located outside West Bengal, as may be notified from time to time by the West Bengal Minorities Development and Finance Corporation, are also eligible for applying.

#### **Swami Vivekananda Merit-cum-Means Scholarship Eligibility Criteria:**

- ❖ The candidate must be a native of West Bengal.
- ❖ The student must be in a higher secondary level or above in the recognised institutes of West Bengal.
- ❖ The annual income of the applicant's family should not exceed the range of Rs.2.5 lakhs per annum.

### **Oasis Scholarship:**

**(<https://oasis.gov.in/>)**

- ❖ The applicant should be a West Bengal resident.
- ❖ The applicant should have a low annual family income to be eligible for the scholarship.
- ❖ The applicant should have scored 50% cumulative marks in the previous final examination.
- ❖ The applicant should have attained a certain number of required attendance.
- ❖ 30% of the scholarship programmes are reserved for female students.
- ❖ The scholarship will be given to only 2 applicants from the same family or blood relation.
